

## HEERF III Student Funds

Midland College (MC) signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

MC received the third round of HEERF III funds (\$3,602,250) during the summer of 2021 and rolled over \$389,642.60 from previous disbursements. Approximately 5000 unduplicated students will be eligible by the end of the 2021 – 2022 school year.

## HEERF II Funds

Midland College (MC) received the second round of relief in February 2021. MC rolled forward \$69,451 from the CARES I funds.

### Initial Disbursement Spring 2021

An estimated 2660 MC students were eligible for the \$905,952 based on the following requirements:

- Enrolled in at least 3 credit hours
- Completion of the Spring 2021 CARES application
- Credential seeking (non-dual, transient, casual)
- US citizen or permanent resident

April 2021, the following student groups were also approved

- Dual credit students (1904 students) enrolled in at least 3 credit hours
- Workforce Continuing Education Students (299 students) enrolled since March 2020

### HEERF I/CARES I Funds

Midland College (MC) signed and returned the funding certification and agreement form for the student portion (at least 50%) of the Higher Education Emergency Relief Fund (HEERF) allocation on April 25, 2020. MC has used, or intends to use the Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act funds to provide emergency financial aid grants to students affected by the disruption of campus closures due to the COVID-19 response.

An estimated 1054 MC students were eligible for the \$836,501 based on the following requirements for Fall 2020 disbursement:

- met eligibility requirements for Title IV funds based on a completed a 2020-2021 FAFSA
- must be enrolled in at least 3 credit hours
